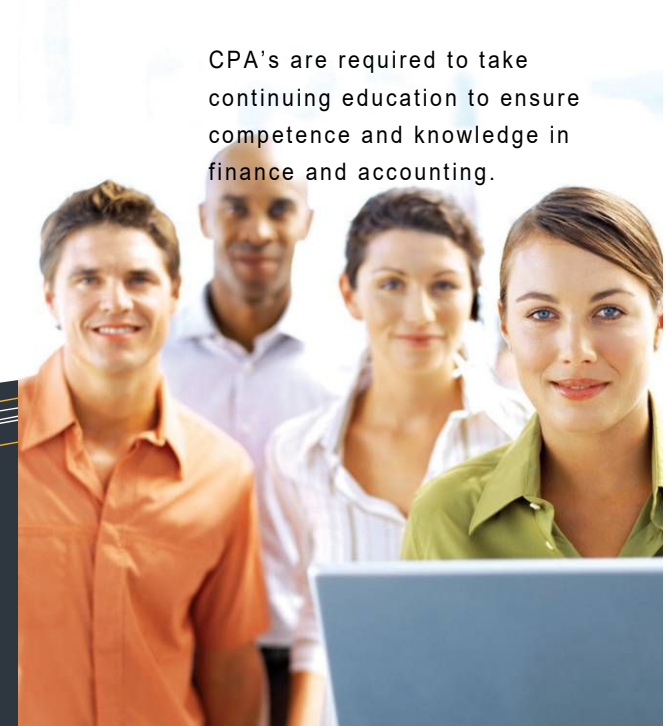


### Continuing Education for IRS Enrolled Agents and Enrolled Retirement Plan Agents
